Containers purged of flammable liquids/vapors. Follow confined space guidelines. FIRE WATCH/HOT WORK AREA MONITORING  $\sqrt{\phantom{a}}$ Fire watch will be provided during and for 30 minutes after work, including any coffee or lunch breaks. Fire watch is supplied with an extinguisher, and/or water pump can, also making use of other extinguishers located throughout work area.  $\overline{\mathbf{A}}$ Fire watch is trained in use of this equipment and familiar with location of sounding alarm.
